Richland County LEPC Meeting Minutes October 4, 2023

Members present:

- 1. **Meeting called to order** at 6:08 PM by Brandon Fetterly and a roll of all in-person and virtual participants occurred. A sign-in sheet was circulated for signatures of those who were present.
- 2. **Proof of notification** was provided by Darin Gudgeon. It was reported that notification was properly posted and published (Media, City Hall, Brewer Library & Courthouse).
- 3. **Motion to approve agenda** occurred with Chris Kanable moving to approve the agenda as presented, seconded by Brandon Fetterly. The motion carried.
- 4. **Approval of minutes from the October 27, 2022 LEPC Meeting** occurred with a motion from Amber Burch and a second from Darin Gudgeon. The motion carried.

5. Director's report:

- a) Darin Gudgeon brought the committee up to speed on the toxicological implications of the widespread presence of PFAS (Per- and PolyFluoroAlkyl Substances) in the environment. It is understood that the WDNR is taking the lead on prevention and remediation with support from Public Health and potentially the Emergency Management community. To the best of everyone's knowledge, there is no level-of-concern contamination in Richland County yet. La Crosse may have measurable contamination though; the implication being that it may soon impact us here. There are several known sites across the State that have been identified as PFAS hotspots. It's also known that fire departments have used PFAS-containing foams on structure fires. The committee recommends asking RCFD about when they started using foam and whether or not it had PFAS in it. Chair Brandon Fetterly agrees that the issue should be kept on future LEPC agendas as a way to track issues as they arise.
- b) The exercise grant previously applied for should reopen again the 3rd week of December, going into January 2024. Mr. Gudgeon recommends resubmitting the application. Much of the information submitted before will not have changed from the last cycle, making this submission quick and straightforward. The grant would fund an exercise that would satisfy EPCRA exercise requirements (particularly at the Functional/Full-Scale level). A contractor would need to be identified and a small design team assembled. The exercise being funded in 2024 would be Full-Scale.
- 6. Public Comments and Input: There were no public comments offered during the meeting.

7. New Business

a) EPCRA Plan of Work Administration

- 1. The LEPC membership list for 2023 was reviewed and discussion revealed that a number of updates were needed. The changes were noted and will be entered into the most recent spreadsheet. The new list should be ready by month's end. Billy Jones moved to approve the updates as discussed. Darin Gudgeon seconded. The motion carried.
- 2. Per the annual review requirement, the topic of EPCRA Bylaws was listed on the agenda so any requested changes could be identified and acted upon. The Chair, Director and Membership did not identify any. Everything that needed to be updated was finalized in 2022. No formal action is required this year. The bylaws stand as presented.
- 3. The Integrated Preparedness Plan requirement, as newly rolled out by WEM was explained in further detail. Richland County wrote its IPP during the 2023 planning year. The following five (5) priority areas were discussed: Priority 1: Active Threat Incident Management; Priority 2: Multi-agency Coordination and Disaster Response; Priority 3: Integrated Disaster Planning; Priority 4: Public Information and Media Relations; Priority 5: EOC Operations. An "Additional Training Matrix" was included, as shown below:

With respect to the exercise schedule, in part, some of the new requirements were discussed earlier by Mr. Gudgeon during his Director's Report. With the new IPP in place, the exercise schedule shifts somewhat. In particular, the original EMPG exercise requirements get subsumed into the new preparedness plan. While that offers some flexibility in meeting EPCRA requirements, EPA continues to expect the standing three year schedule to be followed: Year 1: Tabletop; Year 2: Tabletop, Functional; Year 3: Tabletop, Full-Scale. The IPP needs to account for this and accommodate it accordingly. The IPP for Richland County will span a three year cycle, with updates being made annually, adjustments and modifications being made where and as necessary.

b) Approve New and Updated EPCRA Facility Off-Site Plans:

John Heinen provided a report on those facilities with minor changes in the amounts of chemicals/products as part of their offsite plans along with a new plan for Schreiber. There were some point of contact changes, some Annex vs ESF updates and a few other section details in need of revision. There were no major changes made to any of the plans this cycle.
